SUSPENSION CUM -SHOW CAUSE NOTICE

Whereas, M/s Din Dayal, FPS-6108 under circle-47 (Deoli) has to function in accordance with the terms & conditions of license issued under Delhi Specified Articles (Regulation of Distribution) order, 1981.

Whereas, the police authority of Sangam Vihar Police Station informed on 01/12/2023 that on basis of complaint received on 100 number, a vehicle is held by them allegedly caring SFA's meant for public distribution and the vehicles pertain to FPS No-6108, 8410 & 8975. All the three FPS were inspected by the circle FSO & were sealed on 01/12/2023 due to non-cooperation by the licensee.

Whereas, the above said FPS was inspected by a team consisting of Sh. Suresh Kumar, FSO C-47, Sh Mahavir Prasad FSI C-47, Sh Gehlot Meena FSI C-45, Sh Dinesh Singh FSI Crack Team & Sh. Harish Kumar FSI Crack Team on 04.12.2023 at 07:30 P.M, after receiving application for de-sealing from licnesee. The team was deployed by Assistant Commissioner (South) as per order no File No.AC(S)/F&S/Admn/Misc/362F/1375 dated 04.12.2023. The inspection team reported following discrepancies.

- 1. The combined variation of SFAs was found 29031 Kg Short. (13896 Kg Wheat & 15135 Kg Rice).
- 2. Stock Board was not updated.
- Sample of SFA was not available.
- 4. Entitlement Board was not available.

Whereas, it is a violation of terms & conditions of license issued under Delhi Specified Articles (Regulation of Distribution) Order, 1981.

Whereas, the licensee's nominee Ms Radha Devi and Sh Ghanshyam Singhal informed that they have additional godown whose permission copy was provided. The FSO (C-47) of the circle informed that no such permission is issued him on 11/09/2023 vide dispatach no 454. The Licensee has tempered the dates in r/o earlier temporary permission issued to him on 11/07/2022 having same dispatch no i.e. 454.

In view of the facts mentioned above this is a case of forgery as the licensee has misrepresented the facts with respect to godown by tempering the dates on earlier permission. Therefore, the SFAs kept at godown are not taking into account, which makes variation to tune of 29031 Kg.

Now, keeping in view, the above variation and the guidelines of the department, I, Manoj Kumar, Assistant Commissioner (South)/link Officer, Department of Food, Supplies and Consumer Affairs, Govt. Of NCT of Delhi in exercise of powers conferred upon me under the provisions of Delhi Specified Articles (Regulation of Distribution) Order, 1981, is hereby SUSPENDS the authorization of FPS License No.-6108 in the name & style of M/s Din Dayal circle-47(Deoli) with immediate effect. & hereby forfeit Rs. 10,000/- (Rs. Ten Thousand Only) from security money.

Further, the licensee of FPS 6108 M/s Din Dayal is directed to appear in person along with written submission on 27/12/23 at 03:00 PM as to why the authorization of FPS 6108 should not be cancelled. In case of non-submission of reply by the licensee, the decision will be taken accordingly.
