ORDER

This Order shall dispose-off Appeal dated 03-02-2025 filed by the appellant, Ms. Priyanka D/o Sh. Hari Krishan, R/o H.No. 270, Village Baprola, Delhi-110043 under Rule 6 of Delhi Specified Articles (Regulation of Distribution) Order 1981 for review of Letters dated 15-05-2018 and 01-01-2025 issued by Asstt. Commissioner (West) and FSO (West), respectively.

1. The Brief Facts of the case are as under:-

- i. That the appellant had made an application for grant of license of one Fair Price Shop (FPS) in notified area in Kunwar Singh Nagar under category SC/ST in Circle-31 (Vikaspuri), Delhi and participated in the selection process.
- ii. And that the appellant was not among the successful candidate while granting license of the FPS.
- iii. And that the letters in question are Rejection Letter sent to unsuccessful candidate signed by Asstt. Commissioner (West) and reply to letter of the candidate by the FSO (West).

2. The present appeal is being filed on the following grounds:

- i. That the appellant was not informed of the details of the marks allotted to the four candidates as mentioned in the rejection letter dated 15.05.2018.
- ii. And that at present more than 5 temporary vacancies of Fair Price shop in Circle-31 (Vikaspuri), Delhi are to be allotted so the claim of Priyanka for allotment of one Fair Price Shop on temporary basis in Circle-31, (Vikapuri), Delhi may be considered and allotted to her.

3. After hearing the contentions, examining the written submissions and perusing other records placed in the case file, it is noted that under Rule 6 of Delhi Specified Articles (Regulation of Distribution) Order 1981, the undersigned is empowered to revise any order passed by self or juniors. The license of a FPS is granted on the recommendation of a Committee headed by respective District Magistrate. The letters in question against which the Appeal is filed is only a Rejection Letter sent to unsuccessful candidate signed by Asstt. Commissioner (West) being Member (Secretary) of the Committee and reply to letter of the candidate by the FSO (West). None of the letters against which the instant Appeal is filed, are Orders' *per-se*, against which Rule-6 of Delhi Specified Articles (Regulation of Distribution) Order 1981 can be exercised.

4. In the light of the aforesaid, the instant Appeal is accordingly dismissed being beyond jurisdiction.

5. Parties be informed accordingly.
