**ORDER**

1. This Order shall dispose of the Appeal dated 30-05-2025 filed by the appellant, Sh. Vinod Kumar of M/s R.G. Store, FPS No. 8926, Circle-09 (Kirari), Shop No. 2/202, Kh. No. 188, Shish Mahal Enclave, Prem Nagar-III, Kirari, Delhi - 110 041 for Review of Order dated 29.04.2025 & 20.05.2025 issued by the Assistant Commissioner (North-West)/Licensing Authority, under Rule 6 of Delhi Specified Articles (Regulation of Distribution) Order 1981 and Targeted Public Distribution System (Control) Order, 2015.
2. The Brief Facts of the case are as under:-
  - i. That the appellant is licensee of M/s R G Store FPS No. 8926, Under Circle-09.
  - ii. And that following discrepancy in stock is noted by the Inspection Team on 24.04.2025-
    - a. Variation of wheat =250.00 kg (Short)
    - b. Variation of Rice = Zero
    - c. Variation of sugar = Zero



Total variation comes to 250.00 Kg (Short)

iii. And that the license of M/s R.G Store, FPS No. 8926 had been cancelled vide Order dated 20/05/2025 while forfeiting the entire amount of security to the State after issue of Suspension Order-Cum-Show Cause Notice vide letter dated 29/04/2025.

3. The appellant, in his instant Appeal has sought relief relying on the following grounds-


- i. That impugned order dated 29.04.2025 & 20.05.2025 passed by Assistant Commissioner (North-West) is illegal and incorrect and cause the irregularity of proceeding as the same has been passed mechanically without considering the fact that the FPS holder is neither involved in any black marketing of SFAs nor violated any provision of Delhi Specified Articles (Regulation of Distribution) Order, 1981.
- ii. And that the FSI didn't count the loose wheat of around 2.5 Qtl. which was laying on floor (upon tirpal/sheet) in the FPS.
- iii. And that on 24.04.2025 AC (NW) and his team has taken the appellant signature on a blank page of a diary.
- iv. And that the AC (NW) has passed the impugned order dated 29.04.2025 & 20.05.2025 illegally and arbitrarily and if the same would not be set aside it would cause great sufferance to the appellant.

4. After hearing the contentions, examining their written submissions and perusing other relevant records placed in the case file, it is noted that-

- i. That as detailed by the Asstt. Commissioner (NW)/Licensing Authority all the loose quantity was taken into consideration and the total quantity of the wheat found to be short by 250.00 (KG).
- ii. And that that the variation statement is also found prepared and has the signatures of the FPS owner.
- iii. And that online transfer of stock also do not justify claim of the Appellant.

5. In the light of the aforesaid, the instant Appeal, being devoid of any merit is accordingly dismissed.

6. Parties be informed accordingly.
