**ORDER**

This Order shall dispose-off Appeal dated 14-11-2025 filed by the appellant, Smt. Mamta W/o Gajanand R/o P-112/B, Prem Nagar, Kirari, Delhi-110086 under Rule 6 of Delhi Specified Articles (Regulation of Distribution) Order 1981 for allotment of FPS to the Appellant in area of Prem Nagar-2, Kirari, Delhi-86 (Circle No. 09-Kirari) under General Category (Woman) on account of sufficient card position subsequent to allotment of 01 FPS in the Circle-09 (Kirari).

1. The present appeal is filed on the following grounds:

- i. That in year 2015, the Department of Food, Supplies and Consumer Affairs, Delhi, invited applications from eligible persons/societies/agencies for issue of authorization to run 9 Fair Price Shops (FPSs) under Public Distribution System in Circle-09 (Kirari).
- ii. And that as many as 17 applicants including the appellant applied for allotment of FPS in response to 1 (One) proposed FPS for notified area of Prem Nagar-2 (under woman category) under the said circle.
- iii. And that the appellant was short listed for interview and was called upon vide interview letter dated 22.08.2015, which was conducted on 03.09.2015.

iv. And that the appellant submitted that as per departmental guidelines and norms there should be 1200 ration cards for each FPS. It is submitted that there are 40 FPSs in the said circle and as of now these FPS are running with 51589 cards. Hence, there are 3600 (approx.) excess cards with them. So, there is scope to accommodate 3 more FPSs in the above circle area.

v. That the appellant has already went through strict interview process against the above vacancy as she was also the shortlisted candidate and was found eligible for the allotment of FPS. So, there is no harm if new/additional FPS is allotted to the appellant keeping in view excess card position.

2. After hearing the contentions, examining the written submissions and perusing other records placed in the case file, it is noted that under Rule 6 of Delhi Specified Articles (Regulation of Distribution) Order 1981, the undersigned is empowered to revise any order passed by self or juniors. The license of a FPS is granted on the recommendation of a Committee headed by respective District Magistrate. There are no Orders of the Licensing Authority against which the instant Appeal under Rule-6 of Delhi Specified Articles (Regulation of Distribution) Order 1981 can be exercised.

3. In the light of the aforesaid, the instant Appeal is accordingly dismissed being beyond jurisdiction.

4. Parties be informed accordingly.
