**ORDER**

1. This Order shall dispose of the Appeal dated 12-09-2022 filed by the appellant, Smt. Anju Rani, Proprietor of M/s Hanuman Store, FPS No. 9340, Circle-08 (Mundka), under Clause-6 of Delhi Specified Articles (Regulation of Distribution) Order 1981 and Targeted Public Distribution System (Control) Order, 2015 against the Order No. F.No. AC/NW/2022/1066 dated 27.02.2022 passed by the Asstt. Commissioner (North-West).
2. The Brief Facts of the case are as under:-
  - i. That the appellant is the proprietor of the Fair Price Shop No. 9340 which is operating in the name of M/s Hanuman Store (hereinafter referred as 'said



- FPS') under Circle-08 (Mundka) in District North-West of Food, Supplies & Consumer Affairs Department of GNCT of Delhi.
- ii. And that the appellant had, vide application dated 31-05-2022, applied for shifting of her FPS No. 9340, Circle-08 (Mundka) to Circle-09 (Kirari).
  - iii. And that the Asstt. Commissioner (North-West), vide its Order dated 27-07-2022 had rejected the request of shifting of FPS from Circle-08 (Bawana) to Circle-09 (Kirari).
3. That the appellant, in her/his instant Appeal has sought relief relying on the following grounds-
- i. That the appellant is a female licensee who was issued license to run FPS 9340 in Circle-08 w.e.f. 21.12.2016.
  - ii. And that the appellant had requested for shifting of her said FPS from Circle-08 (Mundka) to Circle-09 (Kirari) that was rejected by the Asstt. Commissioner (North-West) with the comments, *"After considering the report/remarks of the FSO/FSI Circle -08 (Mundka) and in view of Public Interest the undersigned is of the view that permission for shifting of FPS 9340 from Circle-8 Mundka to Circle-9 (Kirari) cannot be acceded to."*
  - iii. And that a total number of 492 cards are attached with the FPS of the appellant against the Departmental policy of 1200 cards.
  - iv. And that both Circle-08 (Mundka) and Circle-09 (Kirari) are in the district North-West of the Department.
  - v. And that Circle-09 (Kirari) has a total number of 41 FPS with 53147 cards and considering maximum 1200 cards to a FPS will enable 3 more FPS in the area.
  - vi. And that with 492 cards, the appellant is finding it difficult to run based on the margin received.
4. After hearing the contentions, examining the written submissions of both the parties and perusing other relevant records placed in the case file, it is noted that, since the said FPS is functioning as usual and that the instant appeal is only in respect of shifting of the FPS out of notified area and more so to a different Circle altogether, it is more of an administrative issue and needs to be settled in compliance of Departmental policies and Orders and is not a case per-se.
5. However, it is noticed that there are 297 FPS in the district with a total number of 296792 cards, taking an average of close to 1000 cards for every FPS and the



instant FPS is having only 492 Cards. I am of the considered view that having only 492 Cards with the said FPS would be making it economically unviable to operate and since the Department has already issued a detailed policy regarding transfer of PDS outlets from one circle to another vide Circular No. F.3(14)/2002/F&S/Policy/30 dated 31-07-2002, the FPS holder and the Assistant Commissioner (NW) is directed to follow procedure laid down in the above Circular dated 31-07-2002 and to shift her FPS, as requested by the Appellant.

6. The application stands disposed-off.
