ORDER

1. This Order shall dispose of the Application dated 19-09-2019 filed by the appellant, Sh. Surender Chandna, Proprietor of M/s Jai Dayal Bhawani Lal, FPS No. 4472, Circle-33 (Dwarka), under Delhi Specified Articles (Regulation of Distribution) Order 1981 and Targeted Public Distribution System (Control) Order, 2015.

2. The Brief Facts of the case are as under:-

- i. That the Application was the proprietor of the Fair Price Shop No. 4472 which was operating in the name of M/s Jai Dayal Bhawani Lal (hereinafter referred as 'said FPS') under Circle-33 (Dwarka) in District South-West of Food, Supplies & Consumer Affairs Department of GNCT of Delhi.
- ii. That the appellant had tendered his resignation from operating the said FPS citing medical reasons.
- iii. And that the same was accepted by the Asstt. Commissioner (South-West)/Licensing Authority vide Office Order No. F.AC(SW)/F&S/C-34/4472/15 dated 05-01-2019.

- iv. And that while accepting the resignation, the Licensing Authority alongwith forfeiture of entire amount of security of license fee of Rs. 10,000.00.
- v. And that the appellant, vide his instant appeal, has requested for release of the amount of security so forfeited.


3. The appellant has relied on following grounds in favour of instant appeal-

- i. That the allottee of the FPS No. 4472 had resigned from operating the said FPS due to his ill health.
- ii. And that the said resignation was duly accepted by the Asstt. Commissioner (South-West) on medical grounds but with the forfeiture of the amount of security amount.
- iii. And that the appellant has stated that since no complaint/vigilance case/suspension was there in respect of the said FPS, the forfeiture of security amount without assigning any reason for the same is totally unjustified.

4. After hearing the contentions, examining their written submissions and perusing other relevant records placed in the case file, it is noted that

The FPS holder surrendered his license owing to ill health and there was no complaint/vigilance case/suspension in respect of the said FPS thus the forfeiture of security amount without assigning any valid reason was unjustified. Accordingly, I, Arun Kumar Jha, Addl. Commissioner (F&S)/Appellate Authority, in exercise of powers assigned to me under Delhi Specified Articles (Regulation of Distribution) Order 1981 and Targeted Public Distribution System (Control) Order, 2015 do amend the Orders dated 05-01-2019 issued by Assistant Commissioner (South-West)/Licensing Authority to the tune that Resignation tendered by the FPS holder is accepted while releasing the security amount so forfeited.

5. Parties be informed accordingly.
