CIRCULAR

Sub:- Regarding measures to be taken to avoid large undistributed quantity of ration.

Reference is invited to Hon'ble Minister Food Supply and Consumer Affairs' observation regarding "incorporating time bound action plan for ensuring timely updation of truck chit challans, proper accounting of NFSA ration, ONORC ration and undistributed ration" during the meeting convened on 29.08.2024.

It is directed to take following measures with immediate effect in order to avoid large undistributed quantity in future:-

1. IT Branch, Hq may send the details of pending truck chits challans to the concerned Zonal Assistant Commissioners and direct them to clear the pending truck chits challans within 02 days.
2. All Zonal Assistant Commissioner, F&S shall regularly monitor the data on AePDS portal and ensure that no truck chits challans shall remain pending for acceptance.
3. All Zonal Assistant commissioner shall direct their respective FSOs to regularly make field visit and assess the quantity required by the FPSs and regularly adjust the excess quantity of the FPSs through Stock Adjustment module so that excessive closing balance would not remain with the FPSs.
4. Assistant Commissioner (IT)/All Zonal Assistant Commissioners shall monitor and get the E-KYC expedited so that ineligible beneficiary's will be removed from the PDS beneficiaries list resulting inclusion of eligible PDS beneficiaries and accordingly less accumulation of stock with the FPSs.
5. All Zonal ACs shall properly deal with the request of Stock transfer so that excess stock lying with the particular FPS to be given to those FPSs where it is required


