**SUSPENSION CUM -SHOW CAUSE NOTICE**

Whereas, M/s Janta Store, FPS No-7498, under circle-51 (Kalkaji) has to function in accordance with the terms & conditions of license issued under Delhi Specified Articles (Regulation of Distribution) order. 1981.

Whereas, on the request of licensee, the FPS was shifted from TA-183 A, Gali No-3 Tughlakabad Extension, New Delhi-110019 to C-255-A, Nehru Camp, Govindpuri, Kalka Ji, New Delhi-110019 for renovation purposes vide order dated 29/04/2022.

Whereas, the said property has already been renovated and the licensee has not shifted back even after passing of considerable time. The licensee has been directed many times orally & in written also, to shift her FPS to the old address for which the license was granted, by the FSO office & Assistant Commissioner South office.

Whereas, in her reply licensee submitted that she is unable to run the FPS due to hike of rent in old area, which is not acceptable

Whereas, on the last occasion on 09/07/2024, the licensee submitted that she will shift her FPS to the old address or nearby to the old location but till date the licensee has not still shifted to her old address or nearby location

Whereas, in the absence of non shifting to the old address, the license has not been renewed which has already been expired.

Whereas, it is a violation of terms & conditions of license issued under Delhi Specified Articles (Regulation of Distribution) Order, 1981

Now, therefore, keeping in view of the public interest, I, **Vinod Kumar, Assistant Commissioner (South)**, Department of Food, Supplies and Consumer Affairs, Govt. Of NCT of Delhi in exercise of powers conferred upon me under the provisions of Delhi Specified Articles (Regulation of Distribution) Order, 1981, is hereby **Suspend** the authorization of FPS License No.-7498 in the name & style of M/s Janta Store, under circle-51(Kalkaji) with immediate effect & hereby forfeit Rs. 10,000/- (Rs. Ten Thousand Only) from security money.

Further, the licensee of M/s Janta Store, FPS No-7498 is directed to appear in person along with written submission on 27/11/2024 at 3.30 P.M. In case of non submission of reply by the licensee, the decision will be taken accordingly.
