Sub: Directions for Monthly distribution of Specified Food Articles (SFAs) under NFSA, 2013 to FPS Licensees.

Consequent upon change in the quantity of monthly allocation in respect of NCT of Delhi, as per direction received vide letter No. 1-8/2013-BP-III (Vol- II) Pt.(e-323732) dated 28/11/2025, it is directed that the distribution of SFAs under National Food Security Act, 2013 to eligible beneficiaries shall be made as under till further orders:-

1. The regular entitlement of food grains under NFSA w.e.f. January, 2026 is as under:

Household Category	Regular Entitlement of Food Grains	
	Wheat	Rice
PHH	4 Kg per beneficiary/member	1 Kg per beneficiary/ member
AAY	28 Kg per household	7 Kg per household

2. The distribution of Sugar to eligible AAY beneficiaries is stopped till further orders.
3. That the rest of content of the previous order of even number dt. 31.10.2025 shall remain same.
