The main objective and the functions of the District Level Vigilance Committee will be as under-

- i. The District Level Vigilance Committee shall be authorized to redress/solve the problems at its level to the maximum extent possible and whenever it is not possible, it would refer the same with its recommendation to the State level Committee.
- ii. To which and suggest measures for prevention of the cases of short supply, less weighment, over-charging and distribution of sub-standard quality of SEAs by FPS holders.
- iii. To suggest measures to prevent the issuance of bogus cards.
- iv. To supervise regularly the implementation of all schemes under the National Food Security Act 2013
- v. To inform the District Grievance Redressal Officer in writing of any violation of the provisions of National Food Security Act 2013
- vi. To inform the District Grievance Redressal Office in writing of any malpractice or misappropriation of funds found by it.
