**ORDER**

Whereas the Administrative Units of NCT of Delhi has been re-organized into 13 Revenue Districts vide Delhi Gazette Notification dated 25.12.2025, making them fully co-terminus with the jurisdictional boundaries of the Municipal Corporation of Delhi (MCD), NDMC and Delhi Cantonment Board;

And whereas, the Chief Secretary, Govt. of NCT of Delhi, vide Communication dated 25.12.2025, directed all Departments to modify their existing administrative and operational area to ensure complete co-terminus alignment with the revised Revenue Districts boundaries;

And whereas, Food, Supplies & Consumer Affairs Department of GNCT of Delhi, presently having 9 District offices, is now required to be re-organized into 13 Districts for making it co-terminus with newly created 13 revenue districts of the Revenue Department, GNCTD;

Now, therefore, in supersession of all previous orders relating to creation of District offices of the Department and for making it co-terminus with the newly created 13 Revenue Districts of the Revenue Department, District offices of the Department are hereby re-organized into 13 Districts as under:


