ORDER

The instant stay application cum review appeal has been filed by the appellant under Clause 6 (6) of Delhi Specified Articles (Regulation of Distribution) Order, 1981 challenging the order dated 06-01-2024 passed by the Assistant Commissioner (West), whereby the authorization/Fair Price Shop license of the appellant has been cancelled.

1. None present on behalf of Appellant.
2. Sh. Vinod Kumar, FSO C- 29 Respondent was present.

Brief Facts

1. The matter was earlier adjudicated by this Authority in Appeal No. 07/2022 dated 04-07-2023, wherein it has been noticed that there was an order dated 16-02-2023 already passed by previous Appellate Authority wherein the matter was remanded back to licensing authority for further necessary action.

2. Pursuant to the remand directions, the Assistant Commissioner (West) issued notices to the appellant, afforded an opportunity of personal hearing, considered the material available on record and thereafter passed the order dated 06-01-2024 and upheld the cancellation order dated 24-06-2016 of the Licensing Authority.

3. Aggrieved by the said order, the appellant has filed the present review appeal before this Authority.

Submissions

The appellant reiterated the grounds taken in the memorandum of appeal and submitted to allow a stay on the cancellation of Fair Price Shop.

The Appellant has added nothing new in his present Review Appeal and stating the same submissions which ~~was~~^{were} earlier considered and not acceded to.

Findings

I have carefully considered the appeal, the submissions advanced by FSO Circle-29, the records produced before me and the impugned order passed by the Assistant Commissioner.

It is observed that the Assistant Commissioner has duly complied with the directions contained in the remand order passed by this Authority. The appellant was afforded adequate opportunity of hearing and the material available on record has been duly considered but the reply given by the Appellant was not found satisfactory.

The impugned order is a reasoned and speaking order dealing with the allegations and evidence in detail. During the course of hearing this Authority has not noticed any procedural irregularity, violation of principles of natural justice or any legal infirmity in the impugned order.

The grounds urged in the present review appeal are substantially the same as those already considered by the Assistant Commissioner (West) while passing the impugned order. No fresh material or cogent evidence has been produced in this Appeal to dislodge the findings recorded therein.

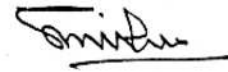
Accordingly, this Authority finds no merit in the present review appeal.

Order

The order dated 06-01-2024 passed by the Assistant Commissioner (West) cancelling the authorization/Fair Price Shop licence of the appellant is hereby affirmed.

The review appeal stands disposed of accordingly.

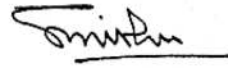
