ORDER

1. This Order shall dispose of the Application dated 02-07-2024 filed by the appellant, Sh. Rattan Jain, Proprietor of M/s Puran Mal Jaipal Jain, FPS No. 1108, Circle-21 (Matia Mahal), under Delhi Specified Articles (Regulation of Distribution) Order 1981 and Targeted Public Distribution System (Control) Order, 2015.
2. The Brief Facts of the case are as under:-
  - i. That the Application was the proprietor of the Fair Price Shop No. 1108 which was operating in the name of M/s Puran Mal Jaipal Jain (hereinafter referred as 'said FPS') under Circle-21 (Matia Mahal) in District Central of Food, Supplies & Consumer Affairs Department of GNCT of Delhi.

- ii. That an inspection was conducted by the Enforcement Branch on 11-08-2016.
- iii. And that during the said Inspection, the team found total variation of 107.87 Qtls. Of food SFA [80.81 Qtl. Wheat (Short) and 12.89 Qtl Rice (Short)] in addition to various other shortcomings.
- iv. A FIR No. 025A dated 12-09-2016 u/s 154 CrPC was lodged in PS Kamla Market (Central District) under section 7/10/55 of EC Act.
- v. That a Show-Cause Notice dated 16-09-2016 was served by the then Assistant Commissioner (Central)/Licensing Authority.
- vi. And that a Suspension Order dated 21-09-2016 was served upon to the licensee.
- vii. And that an Appeal was filed by the Appellant on 18-10-2016 against the Suspension Order dated 21-09-2016 with No. 137/2016.
- viii. And that the Appellant Authority, vide Order dated 29-12-2016, while remanding back has opined

*"...that if the manual records lying with the appellant regarding disbursal of SFAs to the cardholders for the period when the POS machine malfunctioned, were considered, there would have been no shortage of SFAs, but the same were not taken into account by the licensing authority. Therefore, I am of the view that in the interest of natural justice, the case be remanded back to the licensing authority to give one more opportunity to the appellant and pass speaking order within one month from the receipt of this Order, taking all material facts available on record..."*

- ix. And that, the AC (Central)/Licensing Authority vide Order dated 24-01-2017 had revoked the Suspension Order dated 21-09-2016.
- x. And that vide Order dated 30-01-2017, the AC (Central) has Cancelled the Licence.
- xi. And that a Review Appeal was filed on 06-02-2017 by the appellant.
- xii. And that, the Appellate Authority vide Order dated 21-09-2021 in Review Appeal No. 16/2021; Review Appeal No. 154/2016 & Appeal No. 137/2016, the case was already


*"...remanded back to the Asstt. Commissioner (Central)/Licensing Authority, with the direction to afford one more opportunity of hearing to the petitioner and decide the matter afresh on merits, after due consideration of facts, circumstances and examining documents/contentions adduced by the appellant in the case..."*
