You are, therefore, once again requested to visit the "e-Litigation" portal and identify the court cases pertaining to your zone/branch out of **207 court cases** reflecting on "e-Litigation" portal, while updating the software immediately and send the updated monthly report of October 2015 by **November 5th 2015 to the L&P Branch**.
