Whereas, M/s Sri Chand, FPS No. 5884, Circle-36, through its Prop. Kamla, has filed an APPEAL under Clause 6 (6) of Delhi Specified Articles (Regulation of Distribution) Order, 1981 against cancellation order dated 26.09.2018 passed by the Assistant Commissioner (South-West).

Vide Hon'ble High Court's Order dated 10.03.2021 in WPC 3112/2021 & CM Appl. 9450/2021 titled Prahlad Chand & Ors. V/s Commissioner, Deptt. of Food & Supply, it has been directed that the appeals be considered after affording a hearing to the Petitioners, and shall be disposed of within a period of 30 days. Accordingly, in compliance of Hon'ble High Court Order dated 10.03.2021 and as per direction of Hon'ble High Court an opportunity of hearing to the petitioner has been afforded on 12.04.2021 at 3.00 P.M. at Office of the Commissioner / Appellate Authority, Department of Food Supplies and Consumers Affairs, Govt. of NCT of Delhi, Room No. 101, Ist Floor, Vikas Bhawan, I.P. Estate, New Delhi - 110002.


Shri Shailender, Authorised Representative of the appellant and Shri Desh Raj Singh, Assistant Commissioner (South - West) were present.


