The food grains be issued to Welfare Institutions as per entitlement @ 12 Kg of Wheat and 03 Kg of Rice per inmate per month at BPL rates i.e. Wheat @ Rs.6.45 per Kg and Rice @ Rs.7.95 per Kg. These prices will include FPS holders' margin @ Rs.2.00 per Kg and transportation charges @ Rs.0.30 per Kg.

Subject: Allocation of foodgrains Government of NCT of Delhi under Welfare Institutions & Hostels Scheme for the 2nd half of 2024-25 i.e. from October, 2024 to March 2025.

Sir,

I am directed to convey the approval of the Government of India for monthly allocation of 2.052 MT of wheat and 0.513 MT of rice at the rate Rs. 5.65/Kg for Rice & Rs. 4.15/Kg for Wheat to the Government of NCT of Delhi under Welfare Institutions & Hostels Scheme for the 2nd half of 2024-25 i.e. from October, 2024 to March, 2025.

- 2. Food Corporation of India is requested to ensure that the said quantity of food grains is issued to the representative/nominee of the Delhi Government as per district-wise sub allocation to be made by the Delhi Government on pre-payment basis at the above mentioned rate from their nearest depot. The FCI may issue suitable instructions to their Regional Offices in this regard under intimation to this Department and also ensure uninterrupted supply of food grains from their nearest depot.
- 3. The validity period for deposit of the cost & lifting of allocated food grains for the month of October, 2024 will be 30 days from the date of issue of this letter. For the remaining months (i.e. November, 2024 to March, 2025), the validity period for lifting the allocated foodgrains thereof will be the last day of the month preceding the allocation month and the cost of foodgrains shall be deposited with the FCI so much in advance that the lifting is completed in time.

Commissioner, D/o Food Supplies & Consumer Affairs, Govt of NCT of Delhi: As per the guidelines dated 01.09.2017 and 13.02.2020 (copy enclosed) issued by this Department, allocation of foodgrain under Welfare Institutions and Hostel Scheme are made to States/UTs in respect of Govt. owned/Govt. aided/Govt.run/Govt. sponsored by the State Govt./UT Admn. or Administrative Ministries of Govt. of India subject to furnishing of Utilization Certificate for the last allocation made or for corresponding period of the previous year and uploading the complete details of beneficiary institutions and hostels in the Performa by the States/UTs on their Department's portals.
- (ii). In case of hostels, 2/3rd of hostellers should belong SC/ST/OBC category. However, all the hostellers of such hostels will be eligible to receive foodgrains as per the entitlements. Proper implementation & monitoring of the scheme is responsibility of the State Government. Allocation for 1st half of 2025-26 will be considered only on the submission of pending Utilization Certificate, if any. The State Govt is requested to seek allocation of foodgrains as per extant guidelines as mentioned above.
- (iii). It is requested to place food grain allocation requisition only through the Central Allocation (CALLOC) module. Any allocation requisition sent through any other mode except CALLOC shall not be considered.
