Kindly refer to your letter No. 4-6/2018/Delhi/BP-II (e-File 366298) dated 18.09.2025 vide which Government of India allotted monthly Quota of **1.848 MT of Wheat and 0.462 MT of Rice** at BPL rate to Govt. of NCT of Delhi under Welfare Institution & Hostels Scheme for the 2nd Half (October-2025 to March-2026) of 2025-26. Accordingly, the allocated Quantity was further allotted to Welfare Institutions for 154 inmates as per submission made by the Concerned ACs of this Department. The Utilization Certificate for the above said period will be submitted to MoCAF&PD, GoI as received by the Asstt. Comm.(West), F&S Department via Welfare Institutions.

In respect of allocation for the **1st half of 2026-27 (April-2026 to September-2026)**, our requirement for distribution under the above said scheme among 124 inmates for eligible Welfare Institutions as per list enclosed at Annexure I is submitted as below:-
