ORDER

Shri Mool Chand Gupta, Appellant and Shri Ashok Kumar, Assistant Commissioner (New Delhi)/ Respondent were present.


The appellant submitted that he is the owner of FPS No.5635, Circle-43 (Malviya Nagar) since 20.05.1981 and due to some misunderstanding he filed the present appeal. 
