Sir,

Kindly refer to your letter No. 4-6/2018/Delhi/BP-II (e-File 366298) dated 07.03.2025 vide which Government of India allotted monthly Quota of 1.368 MT of Wheat and 0.420 MT of Rice at BPL rate to Govt. of NCT of Delhi under Welfare Institution & Hostels Scheme for the 1st Half (April-2025 to September-2025) of 2025-26. Accordingly, the allocated Quantity was further allotted to Welfare Institutions for 140 inmates as per submission made by the Concerned ACs of this Department. The Utilization Certificate for the above said period will be submitted to MoCAF&PD, GoI as received by the Asstt. Comm. (West), F&S Department via Welfare Institutions.
