ORDER

Sub: Allocation of food grains and pulses to the Migrants/stranded migrants as part of Economic measures (Atma Nirbhar Bharat)-reg.

In reference to the announcement made by Hon'ble Finance Minister, Govt. of India on 14.05.2020 as part of the Economic Measures (Atma Nirbhar Bharat), it has been conveyed by the Ministry of Consumer Affairs, Food and Public Distribution, Govt. of India to allocate 5 Kg of food grains (4 Kg wheat and 1 Kg rice) per person per month as conveyed vide OM dated 15th May, 2020 of Department of Food and Public Distribution, Govt. of India and also 1 Kg of Dal (Chana Whole) per household per month as conveyed vide DO letter dated 15th may, 2020 of Department of Consumer Affairs, Govt. of India to the migrants/stranded migrants, free of cost for two months i.e. May and June, 2020 who are not covered under NFSA or State scheme PDS cards to benefit them to help mitigate their plight during this precarious COVID-19 situation and to ensure availability to them. As per allocation made by Govt. of India, the benefits would be provided to an upper limit of 10% of beneficiaries under NFSA.

In compliance of the above, for distribution of food grains and pulses under "Atma Nirbhar Bharat" to migrants/stranded migrants in Delhi, the following has been decided:

- 1. Under "Atma Nirbhar Bharat", 5 Kg of food grains i.e. 4 Kg Wheat and 1 Kg Rice per person per month along with 1 Kg of Dal Chana Whole per household per month will be distributed free of cost to the migrants/stranded migrants who are not covered under NFSA or State PDS scheme for two months in one go i.e. May and June, 2020.
- 2. The list of beneficiaries identified for benefits under the scheme will be uploaded on the website of the Department under the tab Atma Nirbhar Bharat.
- 3. The food grains and pulses would be distributed through the existing network of Fair Price Shops.
- 4. For this purpose, initially, the identified beneficiaries, based on the available details on their addresses, have been mapped and linked locality wise to 365 Fair Price Shops. The list of beneficiaries attached is being provided to concerned Fair Price Shops and also uploaded on the website of the Dept.
- 5. The food grains (wheat and rice) will be lifted from FCI godowns by DSCSC Ltd. and pulses will be provided by NAFED at the delivery points of DSCSC i.e godowns at Siraspur and Gazipur. These food grains and pulses will be delivered at concerned Fair Price Shops by DSCSC Ltd. FPS wise allocation details is being provided separately.

- 6. Food grains and Pulses will be distributed to these beneficiaries on production of Aadhaar card or any other valid identity proof and after making necessary entries in the list of beneficiaries as provided by the Department.
- 7. For proper record management, FPS licensees will maintain separate account of stocks and distribution in separate registers for this scheme.
- 8. The report on distribution of food grains and pulses under the scheme will be provided by FPS owners through Circle FSOs/FSIs for onward submission to Govt. of India.
- 9. Information to the beneficiaries to whom the allocation is being made will be made through SMS on their mobile numbers for obtaining their entitled ration through the attached FPS. SMS may also be sent to concerned FPSs on allocation.
