CIRCULAR

Sub: Additional allocation of food grains under "Pradhan Mantri Garib Kalyan Anna Yojana" for Distribution under TPDS-reg.

To ameliorate the hardships faced by the poor due to economic disruption caused by Corona virus (COVID-19), 5 Kg of additional food grains per person per month for three months i.e. April, May and June, 2020 would be provided free of cost by Govt. of India under "Pradhan Mantri Garib Kalyan Anna Yojana" over and above the regular monthly allocation of food grains under NFSA, to all the beneficiaries covered under TPDS as per provisions of NFSA, as conveyed vide letter no. 7-1/2019(i)-BP.III dated: 30th March, 2020 of Department of Food and Public Distribution, Ministry of Consumer Affairs, Food and Public Distribution, Govt. of India. These additional food grains under the scheme have been allocated to Delhi @ 4 Kg Wheat and 1 Kg Rice per beneficiary per month as per revised allocations made vide their letter dated: 17th April, 2020.

- 1. Accordingly, 5 Kg of food grains i.e. 4 Kg Wheat and 1 Kg Rice per person per month will be distributed free of cost to PDS beneficiaries (AAY, PR and PR-S) for three months i.e. April, May and June, 2020.
- 2. This additional allocation is over and above the regular monthly allocation of food grains under NFSA.
- 3. The additional food grains would be distributed through the existing network of Fair Price Shops.
- 4. These food grains will be lifted from FCI godowns and delivered at Fair Price Shops by DSCSC Ltd as per allocation details.
- 5. Necessary provision to accommodate additional allocation will be made in the allocation module by NIC.
