Accordingly, all Zonal Assistant Commissioners and SSA(IT) are directed to strictly ensure compliance of the Orders of Hon'ble High Court and the Department instructions for information and necessary action regarding uploading the details of PDS residents on the website of the Department, at the end of each day.

Let the replies to the present application be filed within a period of three working days from today with advance copies to counsel for the applicant/petitioner, who may file rejoinder thereto, if any, before the next date of hearing.

We have heard learned counsel appearing on behalf of the petitioner/applicant, as well as, learned counsel appearing on behalf of the respondents, including particularly counsel appearing on behalf of Government of National Capital Territory of Delhi (for short 'GNCTD'), at length.

We observe that, the distress caused to the residents of the city, by the ongoing lockdown imposed in order to contain the spread of the COVID-19 virus, has been further aggravated by the stated denial of access to food grain to the poor, under-privileged and marginalized sections of the populace, even though we are informed at the Bar that, the GNCTD is undertaking necessary steps to alleviate their suffering through various measures, stated to include the serving of hot meals twice a day at a large number of specified locations.

We, therefore, direct that, in the meantime, the GNCTD shall ensure that, all ration shops remain operational and disburse PDS food grains, in accordance with the policy formulated by both the Central Government, as well as, the State Government in this regard; and further ensure delivery of the requisite food grains from the PDS ration shops, on a regular basis between 09:00 a.m. to 01:00 p.m. and 03:00 p.m. to 07:00 p.m., on all seven days of the week.

The GNCTD shall also ensure that food grains are distributed to the poor, needy and marginalized non-PDS residents from the PDS, as well as, other distribution centers stated to be set-up by them, for the said purpose.

The GNCTD shall further ensure that the Sub-Divisional Magistrates of each district carry out strict and regular monitoring and oversight of the distribution of food grains, as afore directed and upload the details of shop-wise distribution of ration to both the PDS (and non-PDS) residents on their official website, at the end of each day.

The GNCTD shall furthermore, widely publicize and circulate the information qua the compliance of the directions issued hereinabove, both through the print and electronic media, on a daily basis.

The GNCTD is also directed to immediately place on their official website, as well as, publicize through the print and electronic media, Grievance Helpline Numbers, so as to enable members of the public, who may be aggrieved qua the lack of distribution of the food grains, to seek redressal of their grievances, by contacting the Nodal Officers appointed for the said purpose, whose details shall also be placed in the public domain, forthwith.

The Nodal Officers shall address the grievances so received and respond to the persons aggrieved, by placing on the official website the action taken by them in that behalf.

A copy of this order be provided to learned counsel appearing on behalf of the parties electronically. A copy of this order be uploaded on the website of this Court forthwith.

Sub : Daily Reporting format for PDS, FPS Licensee's.


In continuation to this office letter no. F.2(200)/F&S/IT/2020-2021/143 dated 21/04/2020, the reporting format has been modified wherein one more section has been added to enter the details of Grocery Kit distribution. The modified reporting format has 5 section as given below :-

- 1) FPS Licensee details and the cards attached.
- 2) Opening Stock details.
- 3) Beneficiary and distribution details.
- 4) Closing Stock details.
- 5) Grocery Kit distribution details

The concerned FSO/FSI are responsible for ensuring the filing of requisite report by all the respective FPS licensee's. Non reporting or non filing of report by the FPS licensee's shall be viewed seriously and will be a cause of action against FPS Licensee. The report will be placed on the website of the department for general information and record keeping.

Sub: Allocation and Distribution of free Ration under NFS for May, 2020, under PM-GKAY for April, 2020 and Kit of Essential Items under Mukhya Mantri Corona Sahayta Yojana and Related Directions to FPS Licensees


1. The entitled food grains under NFS for the month of May, 2020 will be provided free of cost to all the entitled PDS beneficiaries @ 4 Kg Wheat and 1 Kg Rice per beneficiary to PR and PR-S cardholders and @ 25 Kg Wheat & 10 Kg Rice and 1 Kg Sugar per Household to AAY cardholders.
2. In addition to the above regular entitlement for the month of May, 2020 under NFS, 5 Kg of additional food grains i.e. 4 Kg Wheat and 1 Kg Rice per beneficiary member and 1 Kg Channa Dal per household will be distributed free of cost to all PDS beneficiaries (AAY, PR and PR-S) under Pradhan Mantri Garib Kalyan Anna Yojana (PM-GKAY) for the allocation month of April, 2020.
3. One Kit of Essential Items per household will also be distributed free of cost to all PDS beneficiaries for May, 2020 under Mukhya Mantri Corona Sahayta Yojana.
4. The total entitlement including the food grains under NFS for the month of May, 2020, additional entitlement of food grains and pulses under PM-GKAY for April, 2020 and Kit of essential items under Mukhya Mantri Corona Sahayta Yojana for May, 2020 will be as under:

5. A Board detailing total entitlement of beneficiaries including the regular NFS entitlement as well as additional entitlement to be provided under PM-GKAY and Mukhya Mantri Corona Sahayta Yojana in the **above format** will be **mandatorily displayed prominently** at all Fair Price Shops by the FPS Licensees.
6. The regular entitlement for the month of May, 2020 along with the additional entitlement under PM-GKAY and Mukhya Mantri Corona Sahayta Yojana for the month of April, 2020 will be distributed at Fair Price Shops from **29th April, 2020** in a graded/staggered manner for ensuring convenience of beneficiaries and smooth distribution of ration with adherence to social distancing norms, without any chaos.
7. The sale of food grains for the month of April, 2020 will be closed on 28th April, 2020 and the closing balance of the stocks be recorded. Details on sale of food grains and stock closing balance for April, 2020 for regular entitlement and additional entitlement, separately be given by FPS licensees to concerned Circle FSO by 5th May, 2020.
8. Distribution of regular entitlement under PDS for the month of May, 2020 will be made from the remaining quantity of food grains for the allocation month of May, 2020 and the food grains being delivered at Fair Price Shops by DSCSC Ltd. for the allocation month of June, 2020. The quantities of May, 2020 used as additional food grains for April, 2020 are being recouped through FCI.
9. Delhi State Civil Supplies Corporation Ltd. shall ensure delivery at FPSs of food grains and pulses under PM-GKAY for the month of April, 2020 and of food grains under NFS by 28th April, 2020 for distribution to start from 29th April, 2020. Procurement, packaging and delivery of kits of essential items under Mukhya Mantri Corona Sahayta Yojana will be undertaken by DTTDC.
10. Keeping in view relatively large quantity of food grains to be distributed, FPS holders may appropriately draw out distribution plans at the local/ground level in consultation with beneficiaries on distribution of food grains. FPS holders should inform the beneficiaries that the supply of ration would be available in sufficient quantity and beneficiaries may revisit in case there is rush at FPS. Social distancing norms i.e. at least one meter distance between beneficiaries should be maintained. The beneficiaries should be encouraged to wear masks and use hand sanitizers.
11. FPS licensees should observe necessary precautions to ensure their safety and also of the beneficiaries while distributing ration. Hand sanitizers and face masks will be provided to FPSs by the Department.
12. The sale of Specified Food Articles under regular allocation (NFS) as well as under Pradhan Mantri Garib Kalyan Anna Yojana (PM-GKAY) and Mukhya Mantri Corona Sahayta Yojana will be allowed open by Circle FSOs/FSIs at Fair Price Shops as per the Distribution Plan.
13. Fair Price Shops will distribute the food grains and kits of essential items to the beneficiaries on all seven days of the week. In public interest, there will be no weekly off.
14. Accounts for sale and distribution of SFAs under NFSA, additional food grains and pulses under PM-GKAY and kits of essential items under Mukhya Mantri Corona Sahayta Yojana shall be

maintained separately by FPS holders for proper accounting and record management, to avoid any confusion at later stage.

15. One Civil Defense Volunteer will be deployed at Fair Price Shops to assist FPS holders in distribution of ration and crowd management.
16. The arrangement of additional storage space for storage of foodgrains for distribution of enhanced/additional quantities may be made wherever required. The guidelines have already been issued in this regard vide circular no. F. No. 15(41)/CFS/Dist/2020/872-82 dated 26/03/2020.
17. The availability and distribution of food grains and kits at Fair Price Shops shall be closely monitored by Zonal Assistant Commissioners, Circle FSOs/FSIs. It shall be ensured that the commodities are distributed to the beneficiaries conveniently and strictly as per the entitlements under the schemes.
18. Daily reporting on distribution of food grains and kits under these schemes by FPS licensees through Google forms devised by IT branch to monitor the distribution of ration to the PDS beneficiaries will be mandatory.



F. 15 (46)/CFS/Dist/2020/PMGKAY/1198-1211 dated 23/04/2020 wherein FPS licensees were directed to submit daily reports on distribution of ration via online mode through Google Form-as per link provided in the Order dated 24/04/2020, in view of representations received from some FPS licensees regarding inability to submit daily report through Google Form, FPS licensees are directed to submit daily report on the distribution of ration through offline mode in the prescribed format as enclosed to their respective Circle FSO/FSIs.

All Circle FSO/FSIs shall collect daily reports in respect of all Fair Price Shops under their jurisdiction and submit/email them to Mr. Ved Kashyap, System Analyst (Nodal officer) at email ID **covid19fsd@gmail.com**, for compilation and onward submission to higher authorities on a day to day basis.

Further, communication has been received from Govt. of India pertaining to authentication of beneficiaries for distribution of food grains under Pradhan Mantri Garib Kalyan Anna Yojana. Accordingly, all Circle FSO/FSIs are hereby directed to ensure personal check on the distribution of ration through Fair Price Shops in their area on a daily basis and verify/ascertain that food grains are being distributed to the right/genuine beneficiaries.
