Sub: Display of Food grains Entitlement prominently at all Fair Price Shops

All Fair Price Shop Licensees are mandated under the provisions of Targeted Public Distribution System (Control) Order, 2015 to display information regarding entitlement of food grains, in addition to other information on a notice board at a prominent place in the shop on daily basis. Directions have also been issued in the past by the Department for ensuring the above. It has been directed vide Order no. F.No.15 (46)/CFS/Dist/2020/PMGKAY/1198-1211 Dated: 23.04.2020 on allocation and distribution of Ration that a Board detailing total entitlement of beneficiaries including the regular NFS entitlement as well as additional entitlement to be provided under PM-GKAY and Mukhya Mantri Corona Sahayta Yojana in the prescribed format will be mandatorily displayed prominently at all Fair Price Shops by the FPS Licensees.

Directions have also been issued by the Hon'ble High Court of Delhi in the matter of WP(c) No. 3182/2020 title as Ramya Kutty Vs. GNCTD & Ors. for putting up a display board on every FPS mentioning entitlement details for availing relief packages.

Accordingly, All FPS Licensees are directed to mandatorily display the food grains entitlements under all present schemes of Government at a prominent place in the FPS for information of beneficiaries. Zonal Assistant Commissioners, F&S shall closely monitor and ensure compliance of the directions.
